Dogs may be moved up to a higher class at the request of the owner provided the time limit for the judge has not been reached. The request must be made to the Trial Secretary no later than noon, Monday, October 18, 2022, to be included in the Judging Schedule/catalog. Dogs qualifying for a title on October 21 and 22, may be transferred to a higher class for the following trials provided the request is made to the Trial Secretary in writing at the trial site by 5pm the day prior to the move-up date and provided that the time limit for the judges has not been reached.

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering these events the exhibitors acknowledge that they are familiar with the rules and regulations of the sport and that their dogs are familiar with and able to perform all exercises safely.
- Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites or any communicable disease and have appropriate vaccinations.
- The Calcasieu Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, theft, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children.
- The Calcasieu Kennel Club reserves the right to substitute any award with one of equal or greater value.
- The Calcasieu Kennel Club does not agree to arbitrate claims as set forth on the official AKC entry form for any of these events.
- Puppies under six months of age are prohibited from the trial grounds.

Entries:

- Checks that have been returned due to insufficient funds do not constitute a valid entry. A \$25 service fee will be added for all returned checks. Entry fees will not be refunded if a dog is absent, disqualified, excused, or barred from competition by the action(s) of the Trial Committee. No entry fee will be returned if the Trial cannot open or be completed by reason of riots, civil disturbance, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Entries must be made on official AKC entry forms or copies and must be complete, bear a valid signature, and include the AGREEMENT AND RULES. Entries with missing information will be returned.

PAYPAL is now available. Email it to: mardi2003@gmail.com. Both sides of the SIGNED entry form MUST be received; make your payment through PayPal. If you already have an account with PayPal, go to <https://www.paypal.com/>, sign in and click on "Send Money", recipient is mardi2003@gmail.com.

IMPORTANT: Please include a \$2.00 processing fee per entry when securing with a credit card. If securing with a bank account, there is no processing fee as no additional fees are charged at the recipient's end. If you do not have a PayPal account set one up at <https://www.paypal.com/> Click on "Sign Up" and follow the directions. There are no sign-up fees to set up an account.

- If entering Rally Advanced, Master or Excellent, or Obedience Open or Utility include your jump height in the appropriate box on the entry form. Catalog order in these classes will be based on jump height.
- No entries shall be made, and no entries shall be accepted, which specify any conditions as to their acceptance. Entries will not be accepted without fees and signatures. Changes, additions, or corrections to entry forms must be received in writing or by email prior to the close of entries. No entry fee will be refunded in the event of errors or cancellations of entries, after the published closing date. Fax options are no longer supported.
- The Calcasieu Kennel Club may decline entries for just cause. It may refuse to receive entries or may remove any dog on account of aggression, disease, deformity, injury, or illness which may affect the dog's physical or mental performance. No one shall have a claim or recourse against Calcasieu Kennel Club, Inc., or any official thereof.
- Should a bitch come into season before the Friday show and owner notifies the show secretary at that time (email/time date stamp) entry fees will be refunded in full. If a bitch comes into season after the start of the show, refunds will be determined on a case-by-case basis. Such bitches will be marked as "Withdrawn in Season" and no AKC fees will be paid and will not be allowed to show in any classes.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and their children. Any exhibitor whose dog or child creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee members, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- All dogs must be on a leash when not in the ring.
- Exhibitors are responsible at all events for being at the ring gate when it is their turn to exhibit. Judges are not required to hold up a class for tardiness. Neither CKC nor any ring steward will be responsible for calling or notifying exhibitors that they are due in the ring.
- Exhibitors are responsible for cleaning up after their dogs at the trial site and motels. Any exhibitor failing to do so may be excused without benefit of refund.
- **DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES.** If any dog seems to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Trial Committee and/or the AKC for disciplinary action. All persons attending this show hereby waive any claim against the Calcasieu Kennel Club and its members, in the event a motor vehicle is entered to rescue a dog from overheating or suffocation due to improper ventilation.
